Read the passage set below and answer the questions:

Midnapore, 13 November, 1994: A red alert has been recently given in the entire region against the attacks of a lone tusker which has a nasty wound on its neck. The wound was perhaps caused by spears or poisonous arrows the villagers use for driving away the herd of elephants, migrating to this region recently.

The three human casualties so far and the wound of lone tusker show the enmity between man and elephants in Midnapur-Bankura belt.

The traditional steps taken by the Forest Department did not give any remarkable result. The herd of elephants have become used to the sight of human beings. The only effective step is driving them away with the help of fire. It works like a magic.

The Forest Department has accepted this fact and supplies burnt mobile, jute-balls and crackers to the villagers for putting up resistance. Some desperate villagers overact in this situation. They wraps spears with diesel soaked jute and make missile with them. By setting them on fire and aim at the elephants from the back. This is a hostile attitude to the elephants and it is a violation of the wild life protection rules. As a result of this, there will be more wounded elephants increasing the number of rogue-elephants.

Love and respect for the elephants is evident among some of the villagers. Some fanatic villager with religious enthusiasm tried to show respect to the 'Ganesh Devta' by going close to the animals. One of those foolish persons is now lying in Midnapore Hospital with ribs fractured.

As for the elephants, the small forests in the region—Garbetta and Jhargram area with water-bodies here and there provide them a nearly perfect habitat. Fodder is inadequate in these forest. So the animals invade the paddy fields and bamboo-groves near the villages.

Whatever may be the reason for migrating of elephants in this region, steps should be taken to save both man and elephant. Both man and animals should live in harmony on this earth.
