The Governor has further been pleased to order that the aforementioned officers will enjoy the **Pay Level-21 of Schedule-I in the Pay Matrix under WBS (ROPA) Rules, 2019** corresponding to **Pay Band of Rs. 37,400-60,000 (PB-5) along with Grade Pay of Rs. 8700/-as per WBS (ROPA) Rules, 2009** as detailed above as personal to them without any change of designation and nature of duties.
