ORDER

In pursuance of Finance Department's Memo. No. 3015-F dated 13.03.2001 read with Memo. In respect of others, pay fixation order may be issued by the Departments / Directorates / Offices in which the officers concerned are presently posted.

4. An undertaking shall also have to be obtained from the officer concerned to the effect that he/she will be liable to refund the amount drawn in excess, if any, due to erroneous pay fixation, in a single instalment, if detected later on.
