ORDER

In terms of Finance Department's Memo No. 10581-F(P) dated 28.12.2012 read with **Memo No. 5100-F(P1)/FA/O/2M/46/23 (N.B) dated 31.08.2023**, the Governor is pleased to order that the following officer of West Bengal Audit & Accounts Service borne in Scale No. 16 (Pre-revised ROPA,1998) and who has completed 24 (Twenty four) years of continuous and satisfactory service on or after 01.08.2023 and who is currently enjoying **Level-19 in the Pay Matrix under WBS (ROPA) Rules, 2019** corresponding to Pay Band of Rs. 28,000-52,000 (PB-4B) along with Grade Pay of Rs. 7600/-as per WBS (ROPA) Rules, 2009, for at least 3 (three) years, be moved to **Level-21 of Schedule-I in the Pay Matrix under WBS (ROPA) Rules, 2019** corresponding to Pay Band of Rs. 37,400-60,000 (PB-5) along with Grade Pay of Rs. 8700/-as per WBS (ROPA) Rules, 2009 with effect from the date mentioned at Column-5 against her name as shown in the '**SCHEDULE**' below:
