2. The Governor has further been pleased to order that the aforementioned officers will enjoy the **Pay Level-21 of Schedule-I in the Pay Matrix under WBS (ROPA) Rules, 2019** corresponding to **Pay Band of Rs. 37,400-60,000 (PB-5) along with Grade Pay of Rs. 8700/-as per WBS (ROPA) Rules, 2009.**

The pay fixation order in respect of individual officers, who are working in different Departments/Directorates/Offices of the State Government, may be issued by the Departments/Directorates/Offices in which the Officers concerned are presently posted.
