**NOTIFICATION**

In pursuance of Finance Department's Memo No. 3015-F dated 13.03.2001 read with this Department's Memo. The said officers shall also become entitled to draw their pay in the revised Pay Band of **Rs. 28000-52000/- (PB-4B) along with Grade Pay of Rs.7,600/- as per WBS (ROPA) Rules, 2009 corresponding to Level-19 of Schedule-I in the Pay Matrix under WBS(ROPA) Rules, 2019** together with usual allowances as admissible in terms of Government orders issued from time to time after fixation of their pay with effect from the dates mentioned above.

3. The pay fixation orders of officers working on deputation in Councils/ Boards / Autonomous bodies will be issued centrally by the Service Records Cell, Finance (Audit) Department, Group-'T'. In respect of others the pay fixation order may be issued by the Departments / Directorates / Offices concerned (of this Govt.) in which they are presently posted.

4. An undertaking shall also have to be obtained from the officers concerned to the effect that he/she shall be liable to refund the amount drawn in excess due to erroneous pay fixation, if any, in a single instalment, if detected later on.
